An online and in-person meeting of the MTCHS Board of Trustees convened at Date, Place, & Time

Call to Order Chairman Wally Hedrick called the meeting to order at 4:00.

Approval of minutes from the January 23 Board Meeting. Nick Crabbs moved **Consent Agenda**

to approve the minutes, seconded by Tiffany Greyson. Motion carried.

Approval of Monthly Financial Statement. Discussion of Ednetics and EL Cohort payments. Motion to approve payment of the bills by Tiffany Greyson,

and Larry Andrews seconded. Motion carried.

Discussion/Action Items Eide Bailly – Cost Proposal of Financial Audit. A full audit report must be

> submitted to the state every year and Eide Bailly does a very good job for us. Discussion of Cost Proposal and reasons for increase. Their fees don't match the WIP, and our contract has held their fees artificially low. Board requests we check state requirements, see if Eide Bailly has a list of ways we could make the

audit easier.

Update on MOU with West Ada. If it is approved at their board meeting, we would need to submit an approved or suggested charter amendment by the end of March. We would get drafts out to the members of the board and go over

amendments at the next board meeting on March 13.

Discussion of costs for an architectural concept rendering which could be shown to prospective donors. Motion to spend no more than \$6000 on an architectural

rendering of a new facility by Diane DeSpain, seconded by Nick Crabbs.

Motion carried.

Discussion of a working session that would look at the program on the development side, and what Meridian Tech would look like over the next 15 – 20 years. Wally requested board to come in at 3:00, preferably in person, for a

working session an hour before the next board meeting on March 13.
