4:00 p.m. on Monday, September 11, 2023. The meeting was held at Meridian Technical Charter High School, 3800 N. Locust Grove, Meridian, Idaho.

Call to Order Chairman Wally Hedrick called the meeting to order at 4:00.

Consent Agenda Approval of minutes from the August 21 Board Meeting. Larry Andrews moved

to approve the minutes, seconded by Diane DeSpain. Motion carried.

Approval of Monthly Financial Statement. Motion to approve payment of the bills by Jim Bradbury, seconded by Larry Andrews. Motion carried.

**Discussion/Action Items** 

2023-2024 Continuous Improvement Plan. Goals and language are relatively the same. Discussion of graduation rate, college and career readiness, internship program, SAT scores. Scores have come down since COVID, we're working on getting those back up. Discussion of staff performance. Motion to approve the 2023-2024 Continuous Improvement Plan by Nick Crabbs, seconded by Larry Andrews. Motion carried.

Room 110-111 PC Build Pricing. Time to upgrade lab desktops. We buy the components and Seniors will build the computers. Current cost of \$27,736 may fluctuate, requesting up to \$30,000. Motion to spend up to \$30,000 for 29 PCs for 110-11 by Larry Andrews, seconded by Jim Bradbury. Motion carried.

Proposal for Growth. Asking West Ada Board to approve program expansion of no more than 250 additional students, with a three-phase facility and development program over the course of 7-10 years. The proposal shows that we aren't in competition West Ada, because of our unique program. Discussion of what we do now, and the direction we wish to move in. Motion to approve Proposal of Growth to be presented to the West Ada School Board by Nick Crabbs, seconded by Jim Bradbury. Motion carried.

Tiffany Greyson has submitted a letter of resignation due to time constraints with her job and family, but wants to stay involved with the school. Motion to accept Tiffany's resignation by Diane DeSpain, seconded by Larry Andrews. Motion carried.
