4:00 p.m. on Monday, January 22, 2024. The meeting was held at Meridian Technical Charter High School, 3800 N. Locust Grove, Meridian, Idaho.

Call to Order Chairman Wally Hedrick called the meeting to order at 4:01.

Consent Agenda Approval of minutes from the December 18 Board Meeting. Larry Andrews

moved to approve the minutes, seconded by Diane DeSpain. Motion carried.

Approval of Monthly Financial Statement. Motion to approve payment of the

bills by Staci Low, seconded by Diane DeSpain. Motion carried.

Discussion/Action Items Laptop Bids: 2024 purchase of 60 new laptops. Discussion of minimum

requirements for student laptops. The laptop with the best price that met our specs is the HP ProBook 455 G10; the same model as last year, but a step up and better price. Recommend purchase from Right! Systems at \$820 each. Nick Crabbs motioned to approve purchase of the laptops for \$49,200, seconded by

Larry Andrews. Motion carried.

Snow Day and Calendar adjustments. We've had three Snow Days called by West Ada. Emergency Closures must be reported to the state. We get eleven hours of emergency closure, and the third day is being made up by changing the Staff Collaboration Day on January 24 to a regular school day. Motion to approve the Certificate of Emergency Closure by Larry Andrews, seconded by
