Call to Order Chairman Wally Hedrick called the meeting to order at 4:00.

**Discussion/Action Items** 

Personnel: Administration Recommendations

- a. We had hired Rick Kennedy for the Director of Development position, but he decided it wasn't right for him. Administration recommends we pivot from what we were trying to do and redirect funds. The first part of this is to recommend hiring Duane Erickson to be the Workplace Coordinator. As our Computer Science teacher and a business owner, he knows our programs and has connections in the business community and is interested in more business outreach. Motion to approve the hire of Duane Erickson for our Workbase Learning Coordinator by Diane DeSpain, seconded by Staci Low. Motion carried.
- b. With Duane doing more of the business outreach, administration is proposing hiring Jennifer Bradford as a Workbase Learning Coordinator/CTE Career Counselor. She has extensive experience in CTE and would teach Employment Prep and Senior Seminar. Motion to hire Jennifer Bradford by Staci Low, seconded by Jim Bradbury. Motion carried.
- c. Julie Grainger Retirement. Julie is one of our math teachers and has been with us for seven years. Motion to approve retirement by Jim Bradbury, seconded by Staci Low. Motion carried.

April 15 is our Annual Board Meeting. Last year we asked board members to commit to two- or three-year terms. Jim Bradbury – two years, Larry Andrews – two years, Staci Low – three years, Diane DeSpain- two years, Nick Crabbs – three years, Wally – three years. No one is up for reelection. We will be looking for a parent representative to join the board.
