Call to Order Chairman Wally Hedrick called the regular meeting to order at 5:04.

Consent Agenda Approval of minutes from the April 15 Board Meeting. Nick Crabbs moved to

approve the minutes, seconded by Staci Low. Motion carried.

Approval of Monthly Financial Statement. Discussion of \$75,000 pass through

funds for West Ada, Safe & Drug Free schools, STEM Grant. Motion to approve payment of the bills by Nick Crabbs, seconded by Jim Bradbury.

Staci Low recommended starting with 215 days. Craig is in Step 5 out of 10. Motion to approve, with possibility of extending days, by Nick Crabbs, seconded by Larry Andrews. Motion carried.
- c. Policy 802.4 Inventory Control and Policy 803.1 Business Operations
 Revision/review of Business Operation Inventory Control policy to comply
 with GASB standards, and mirroring West Ada policy. Motion to approve
 by Staci Low, seconded by Diane DeSpain. Motion carried.
- d. **Request for Disposal** Request disposal of assets worth less than \$500, including wireless access points and laptops. Motion to approve disposal by Larry Andrews, seconded by Diane DeSpain. Motion carried.
